# Managers Report, Resource Policy Wayne Hastie, Manager

## February 2000

#### 1. Regional Plans

A summary of the status of the various Environment Court references on regional plans is attached. Changes from the last meeting are shown in bold.

#### (1) Regional Coastal Plan (Wayne Hastie)

The final outstanding appeal on this Plan has been resolved by the release of Environment Court Decision W 6/2000, which directs the Regional Council to modify the rule which defines the area where driving is prohibited on Titahi Bay Beach. The Court's direction corresponds with the compromise position that the Regional Council had reached with the appellants, the Titahi Bay Residents' Association, in August 1999, but with which Porirua City Council did not agree.

The resolution of the appeal clears the way for the final stages of the Plan preparation process. The Plan will be put to the Policy and Finance Committee on 9 March for adoption before being forwarded to the Minister of Conservation for final approval. The operative date for the Plan will need to be notified in advance. It is anticipated that the Minister will require no more than four to six weeks for the approval process. The Plan should be able to be made operative before the end of April.

#### (2) Regional Plan for Discharges to Land (Kirsten Forsyth)

The Plan became operative on 17 December 1999. Copies were sent to those institutions and organisations listed in the First Schedule to the Resource Management Act 1991 and to other key players. The Plan is also available on the Council's web site.

#### (3) Regional Air Quality Management Plan (Nicki Kinghorn)

We are actively pursuing a resolution to the outstanding appeal by the Moir Street residents in the light of the results of the stack testing of a spray painting operation. We have had little success so far, but continue to pursue a settlement.

The case came up for call-over at the Environment Court on 13 December 1999 and we asked for a hearing date to be set down. The Court set a date in late February for a judicial conference, with a possible hearing in early April if a settlement cannot be reached.

#### (4) Regional Freshwater Plan (Kirsten Forsyth, Murray McLea)

The Plan became operative on 17 December 1999. Copies were sent to those institutions and organisations listed in the First Schedule to the Resource Management Act 1991 and to other key players. The Plan is also available on the Council's web site.

#### (5) Regional Soil Plan (Nicki Kinghorn)

The outstanding appeals on the Plan remain unsolved, and staff are preparing evidence for a hearing. The evidence must be exchanged by the end of February. However, the possibility of an out of court settlement is still being pursued.

### 2. **Regional Plan Implementation**

#### (1) Community and School Beach and Stream Management (Jo Fagan)

We have continued to work with Naenae School to further their involvement in environmental management. The work has focused on developing a water quality monitoring exercise for their Adopt-a-Stream project.

Staff are working with other organisations and individuals to develop a strategy for "Clean up New Zealand 2000", which will occur over a week in September. Staff are also assisting with displays and exhibits for the Hutt River Festival.

#### (2) On-site Sewage Treatment (Kirsten Forsyth)

Consultation is continuing with territorial authority staff on the draft pamphlets that have been prepared for homeowners on on-site sewage treatment.

#### (3) Review of Air Discharge Problems (Nicki Kinghorn)

We are reviewing the information we have about air discharges in the Region to identify the main contributors of pollutants and the areas that we should focus on when promoting non-regulatory methods to mitigate the effects of air discharges. Examination of the consents database, pollution response database, emissions inventory, and air quality monitoring reports has been completed, and problem discharges prioritised. As expected, key sources of air pollution include vehicles, odorous industries and home fires (in some locations at some times of the year). No unexpected sources have been identified.

# (4) Promotion of Code of Practise for the Management of Agrichemicals (Nicki Kinghorn)

Work has continued on this project. Surveys on chemical usage by Regional Council and territorial authority staff were sent out and are being returned for analysis.

#### (5) Sustainable Land Management (Nicki Kinghorn)

A staff workshop will be held on 10 February to prioritise key sustainable land management issues. An objective of the workshop is to begin to develop appropriate means of addressing sustainable land management issues through

non-regulatory methods, such as on-farm seminars, land management guidelines, or care groups.

### 3. Iwi matters (Tracey Whare)

Ara Tahi adopted the proposal for strengthening the relationship between the Council and tangata whenua at its meeting on 1 December 1999. The proposal will be put to the Policy and Finance Committee for formal adoption on 9 March 2000.

Ara Tahi met on 2 February 2000 to discuss the proposed timetable for the year and to receive information on the Long Term Financial Strategy. Ara Tahi set the following priorities for technical workshops for the year:

- 1. The use of Maori hearing commissioners.
- 2. Creating resource consent conditions that protect Maori interests.
- 3. Section 33 transfer of power.

Staff will now set dates for the workshops and prepare the necessary background material. The workshops will be focused on technical rather than policy matters, and therefore involve Council staff rather than Councillors.

#### 4. Staff

Bianca Sullivan resigned from her position as Policy Advisor in the Department and a replacement is currently being sought. Marie Sang retired on the 42<sup>nd</sup> anniversary of her employment with the Council. Marie started work with the Wellington Regional Planning Authority in January 1958 as an Assistant Draughtswoman and served her whole working life with the organisation, which has evolved into the current Regional Council. A farewell morning tea was held to acknowledge Marie's contribution to the Council and its predecessors. A few special guests were invited, including Wallace Ross who was Marie's Manager for 20 years. Marie was valued for her meticulous attention to detail and the clear diagrams she produced. She also managed the "street names" database that is used to avoid duplication of names in the greater Wellington area. We all wished Marie the best for her retirement.
