- (a) kick start funding be netted off the cost of the individual kick start projects.
- (b) patronage growth funding be applied on a pro rata basis to the net cost of all public transport services.
- (c) note that in 2003 there will be a general funding review and at that time the practices set out in (a) and (b) above will also be reviewed to ensure the optimum spread of transport funding.

Councillor Bonner said bus service levels were unsatisfactory and people were waiting at bus stops for longer periods than was necessary.
