Divisional Report

1. **Purpose**

- To comment on the Utility Services Division's financial performance for the six months ended 31 December 2000.
- To outline various other relevant areas of interest or activity.
- To receive the attached activity reports to 31 December 2000 (Attachment 1).

2. Divisional Performance for 6 Months Ended 31 December 2000

Water Supply

While the detailed information has been provided in the six monthly review presented to the Policy and Finance Committee on Thursday, 15 February, a brief summary of the results is provided here. Overall though a very satisfactory result.

Plantation Forestry

A very difficult six months. Volumes are only 60 percent of last year's corresponding period and revenues consequently reflect this – and that has gone straight to the bottom line in terms of deficit. We finally have two crews working and we are hopeful that a small operating surplus will be achieved by year-end. I think this is realistic, as the bottom line has not moved significantly since 30 September 2000. Also the additional roading costs in the Incline area will have to be covered.
