Report to Rural Services and Wairarapa Committee from Helen Marr, Resource Advisor, Policy and Planning

Regional Council Input into District Planning

1. Purpose

To inform the Committee of Regional Council input into the statutory resource management processes of territorial authorities in the Wairarapa.

2. Applications

2.1 Carterton District Council

<u>Non-notified</u> Fearon K J & Johnston A S	Action 2 lot subdivision, Norman Avenue, Waingawa. Made comment about potential reverse sensitivity with neighbouring industrial uses.
Rotman G	5 lot subdivision, Cobden Road, Carterton. Recommended care in siting effluent disposal and dwellings away from streams, and the potential for odour from piggery.
Wilson D	6 lot subdivision, Kent Street, Carterton. Noted potential for surface flooding on the property and supported connection to urban sewerage system.
Oldfield Aggregates Ltd	Landuse consent to extract gravel from the land adjoining the Waingawa River. In progress.
Shotter J & H	3 lot subdivision, Hoeke Road, Carterton. In progress.
Van Bergen C	3 lot subdivision, Craigielea Road, Carterton. In progress.

2.2 Masterton District Council

<u>Notified Applications</u> Hatchard P	Action 5 lot subdivision, Jetty Road, Castlepoint. Submitted on stability of slopes, recommending care be taken with earthworks and stormwater disposal. Also noted that Castlepoint sewerage system due for review and recommended no new lots be created or connected until review completed. Further information on sewerage system received and meets Regional Council's concerns. Received draft decision and requested minor changes to the proposed conditions. Awaiting final decision.

Made a submission noting presence of faultline, soil erosion concerns, and need for water take consent if communal water scheme put in place. Attended pre-hearing meeting and hearing. Final decision received and includes conditions relating to all Regional Council concerns.

Genesis Power Ltd	Application to extend Haunui wind farm. Regional Council consulted at pre-application stage. Made submission reiterating concerns about surface water flows and erosion potential.
Kershaw D	3 lot subdivision, Regent Street, Martinborough. Made brief submission supporting connection of all lots to urban sewerage system.
Greytown Little Theatre	Application to change use of building on Main Street, Greytown, from retail to a theatrette and clubrooms. No submission necessary.
Icke P (Old Winery Café)	Application to erect temporary advertising sign. No submission necessary.
<u>Non-notified</u> Cummins P	<u>Action</u> 3 lot subdivision, Moroa Road, Greytown. Noted proximity of contaminated site, and potential for groundwater contamination.
