- (1) That additional to Decision RW10 of 4 December 2001, the Committee approve a policy to be applied in the Wairarapa Constituency requiring:
  - (a) Meters to be installed for all new underground and surface water takes of 20 litres per second or greater, averaged over a 24 hour period.
  - (b) Meters to be installed for all existing consented underground and surface water takes of 20 litres per second or greater, averaged over a 24 hour period, upon renewal of each current consent.
- (2) That the Committee request staff to review the requirement for water meters for consented water takes of less than 20 litres per second averaged over a 24 hour period, before the next review of the Resource Management Charging Policy.
- (3) That the Committee notes that the development of water metering is part of a long term approach for improved water utilisation in the Wairarapa.
