Concerning RSW 191 – Varroa Bee Mite

Members were advised that a public meeting to discuss the varroa bee mite situation was scheduled to be held on 19 August at the Masterton YMCA.

Concerning RSW 192 – Environmental Discharges

Mr Dalziell asked whether the meeting with Fonterra and regional dairying representatives to progress development of a regional action plan had been held, and stressed the importance of the dairying sector involvement.

Mr Blakemore advised that an initial meeting had been held with Fonterra and a staff member had been appointed as the key contact in the development of the Regional Action Plan. Involvement with regional dairying representatives would follow.

Concerning RSW 200 – Wairarapa Transport Corridor Study

Cr Buchanan reported on progress with the Draft Wairarapa Corridor Study. A meeting was scheduled with all major stakeholders in Masterton on 20 August to obtain feedback of the private sector interest, e.g. Juken Nissho Ltd, logging/trucking companies, etc. A public meeting is also to be held in Greytown on 8 September. It was proposed that the Draft Corridor Plan would then be reviewed and considered by the Regional Land Transport Committee at its November meeting.
