## E 226 **Environmental Education Annual Report**

Councillors suggested that education initiatives could have a higher profile through:

- publicising some of the positive outcomes that have resulted from the education programmes.
- involving schools in events such as the opening of the new extension to the Hutt River trail.

Councillor McDavitt suggested 'transport' as a topic for environmental education in secondary schools. He said he has received many requests from students for relevant information on transport issues recently, which could indicate pupils' increasing interest in such issues and a high level of relevance to the secondary school syllabus. He suggested that Council use this opportunity to extend the Council's programme to include secondary schools. Any programme developed by Council would need to be relevant to secondary schools curriculum and well aligned with assessment criteria.

Councillor McDavitt also proposed that government departments be included in the 'Take Charge' programme. Geoff Skene said that officers had considered involving government departments, using the waste reduction scheme that has recently been implemented at the Council.

## E 227 **Divisional Manager's Report**

### ***Delivery of Key Messages***

Councillor McDavitt pointed out that presentations to territorial authorities on issues such as air quality ought to involve more than problem identification. He said that key messages need to be developed and clearly communicated.

### ***Stormwater***

Councillors indicated they would like to be updated as the regional stormwater strategy is developed. They would particularly like to have input into material that is discussed with territorial authorities.

### ***Kapiti Groundwater – Saline Intrusion Alarm Level***

Councillor Turver requested that a saline intrusion alarm level be determined for Kapiti groundwater. John Sherriff assured Councillor Turver that this work is being progressed this year.

### ***Harbours***

Councillors endorsed the actions of Mike Pryce (Harbour Master) and his staff in responding to the bulk carrier incident on 21 August 2003.

Following some discussion about the appointment of Mike Pryce to the Advisory Committee on the National Port and Harbour Safety System, Councillor Buchanan advised committee members that he would discuss the matter with staff to ensure the process was well managed. Councillor Turver requested that officers regularly report on the Advisory Committee's progress.

***Diagram to Determine Territorial and Regional Authority Responsibilities***

Councillor Evans suggested that the flow diagram used for the parks plan be used as part of the Council's planning processes. The diagram would help define the boundaries of responsibilities for territorial and regional authorities.

While the Committee agreed that the flow diagram was helpful, many felt it should only be used as a guide. There needs to be flexibility in deciding which activities the Council undertakes. Gaps are often at the interface between territorial and regional authorities' responsibilities and often the decision can depend on more pragmatic issues, such as which council is best placed at the time e.g. agricultural collection.

***Wellington Harbour Freshwater Springs***

Councillor Barr stated that the freshwater springs in Wellington Harbour ought to be included in the subject of an investigation as they are an important part of the Harbour's ecosystem. Councillor Buchanan said that while Council could look at funding further study in this area as part of its marine biodiversity programme, the fisheries resource is managed by the Ministry of Fisheries.

E 236 **General Business**

***Council Responsibility for Threatened Eel Species***

Councillor Barr raised the question of whether the Council should support the Department of Conservation's concern for the long-finned eel, which is now defined as a threatened species. He suggested that Council should be involved as it has responsibilities for freshwater biodiversity.

Councillor Buchanan clarified that while the Council is involved in maintaining the habitat and water quality of freshwater it is not its duty to manage fishery issues. This is the role of the Ministry of Fisheries.

The meeting closed at 12 noon.
