HRA 42 **Apologies**

Resolved

Resolved (Mayor Terris/Cr Laidlaw)

- (1) *That a letter be sent to Wellington Tenth Trust to express the Committee's gratitude for the Trust's support in the Strand Park land transfer process.*

Resolved (Cr Laidlaw/Cr Evans)

- (2) *That the report be received and the contents noted.*
- (3) *That it be noted that the completion dates for Strand Park river realignment and Alicetown stopbank upgrade, as set out in the HRFMP, are June 2005 and June 2007 respectively.*
- (4) *That it be noted that the target date for appointing the contractor for Strand Park river realignment is 1 December 2003 and that attempting to complete the river diversion during the period January 2004 to May 2004 is considered too risky to undertake.*
- (5) *That it be noted that Strand Park river realignment and Alicetown stopbank upgrade cannot be implemented concurrently and that the stopbank upgrade has to follow the river realignment.*
- (6) *That the implementation of Option 4 be endorsed, which provides for completing the Strand park river realignment by June 2005, the critical section of the Alicetown stopbank by June 2006 and all remaining stopbank upgrade works by December 2006.*

- (7) *That it be noted the Committee is concerned with the potential hold-up resulting from the Department of Conservation's requirement to establish a marginal strip and, therefore, requests that the Department of Conservation takes urgent action on the matter.*
- (8) *That council officers advise the Committee of any matters of concern that may result in significant delays in the Strand Park project.*

HRA 46 Hutt River Floodplain Management Plan: Progress Report

Officers updated members of the Committee on the progress of the Hutt River Floodplain Management Plan. Committee members were advised of the progress of the Opahu Stream, Belmont, Whirinaki Crescent, Norfolk Street, Port Road, district plan provisions and emergency management projects, and the bed level survey.

It was noted that officers were having some difficulty in getting approval from St. Patrick's College to go onto their land to survey immediately adjacent to the existing Whirinaki stopbank. A meeting between council officers and the school's trustees is proposed to be set up and officers hope this will help to progress the matter. If necessary, the assistance of the Hutt River Advisory Committee chair may need to be sought.
