359 **Public Participation**

Mr M Gibson

Mr Gibson congratulated ex Councillor Yardley for the manner of her resignation as a member of the Regional Council. Mr Gibson said that as a defeated candidate at the last Local Body Elections in 2001 he was somewhat embarrassed to speak about the extraordinary vacancy that now existed as a result of Councillor Yardley's resignation.

Mr Gibson said a similar vacancy had occurred in the Wairarapa constituency in 1997 following the unfortunate death of Councillor Loader. Mr Gibson said Council decided at that time not to appoint the next highest polling candidate. Following the election, the individual had moved to Wellington and had no previous experience as a Regional Councillor. Mr Gibson concluded that the previous situation was different to the current vacancy and that members should decide to commence an appointment process at today's meeting.

Mr D Butler

Mr Butler said he had attended a Regional Council briefing on the recent flood damage in the region and had been impressed by the way that Council's facilities had coped.

Mr Butler said that with the next Local Body Election only several months away the Council should sensibly carry the vacancy caused by the resignation of Councillor Yardley and not make an appointment.

The meeting adjourned at 9.45am and reconvened at 11.17am.

Iwi Costings

Councillor Thomas said that Mr Allard had advised during a recent briefing that Council had spent up to \$420,000 for Iwi over the past 12 months. Councillor Thomas asked for a breakdown of these costs. Mr Harris said an answer will be circulated in the Councillors' Bulletin.
