WRC Holdings Ltd - Dividends

1. Purpose

To note and approve the intention of WRC Holdings Ltd to pay out in dividends 100% of its 2004/05 net profit after tax.

2. Significance of Decision

The matters in this report do not trigger the significance policy of the Council or otherwise trigger section 76(3)(b) of the Local Government Act 2002.

3. Background

On 14 June 2005 the Directors of WRC Holdings Ltd resolved:

"that the Directors of WRC Holdings Ltd approve, subject to satisfying the solvency test, a provision for dividend for the year ending 30 June 2005 equating to 100% of the net profit after tax (excluding revaluation gains and losses), and advise the Wellington Regional Council accordingly".

The above resolution is a record of the obligation of Directors to make such a dividend payout once the 2004/05 annual report for WRC Holdings Group has been finalised. This obligation is consistent with the WRC Holdings Statement of Intent (SOI) for 2004/05.

I expect that the annual report of WRC Holdings Ltd will be finalised during September, with the dividend likely to be paid in October.

This report is the formal advice to the Council of the intention of Directors of WRC Holdings Ltd to pay the dividend.

4. Communications

No communications are required at this stage.

5. Recommendations

That the Committee recommend that Council:

- (1) receive the report
- (2) **note** its contents.
- (3) **approve** the intention of the Directors of WRC Holdings Ltd to pay a dividend to the shareholder equating to 100% of the company's 2004/05 net profit after tax (excluding revaluation gains and losses).
