  - (e) Agrees to require that the Passenger Transport Operational Plan and any subsequent amendments be adopted by Council before formally coming into operation, so as to ensure that the Operational Plan adheres to the vision, objectives, and policies of the Passenger Transport Plan.
  - (f) Adopts the Passenger Transport Operational Plan as set out in Attachment 2, noting that this is a separate, non-statutory document providing detailed solutions, guidelines, and targets, and is in the course of further development.
  - (g) Agrees that the Chair of the Passenger Transport Committee be authorised to approve editorial amendments to the Passenger Transport Plan and Operational Plan prior to publication.
