*Metlink Service Centre – proposal for change**The information contained in this report relates to Greater Wellington making changes to the operation of the Metlink Service Centre. The report outlines contract pricing arrangements, and reveals potential contracting variations. The contract variations have not yet been entered into. Having this part of the meeting open to the public would disadvantage the Council if further negotiations were to take place, as it would reveal the Council's negotiation strategy.
