Raroa Road The information contained in this *tunnel pipe* report relates to Greater Wellington relocation -Regional Council entering into a Increased Contract for the construction of financial pipeline. The preferred Tenderer allocation has not yet been chosen. The report outlines the Council's budget for this tender. Having this part of the meeting open to the public would disadvantage the Council if further negotiations were to take place. The Council has not been able to identify a public interest favouring disclosure of this particular information in public proceedings of the meeting that would override this prejudice.

*That the public conduct* of the whole or the relevant part of the proceedings of the meeting would be likely to result in the disclosure of information for which good reason for withholding would exist under section 7(2)(i) of the Local Government Official Information and Meetings Act 1987 (i.e enable Greater to Wellington to carry out, without prejudice disadvantage, or negotiations).
