# **CDEM Group Appointments**

### 1. Purpose

To enable the Wellington CDEM Group to appoint persons as required under the Civil Defence Emergency Management Act, 2002 (CDEM Act).

### 2. Background

The CDEM Act (Sections 26 and 27) requires Civil Defence Emergency Management Groups (CDEM Groups) to officially appoint Group and Local Controllers (plus alternates).

In addition, the Wellington CDEM Group Plan (Part 5 – Administrative Arrangements) requires the Wellington CDEM Group to formally appoint Recovery Managers (and Alternates), Lifelines Co-ordinator (and Alternate), and the CDEM Group Welfare Manager.

# 3. Group appointments required in the CDEM Group Plan

Appendix 4 of the current Group Plan lists the statutory and non-statutory appointments made by the CDEM Group to give effect to its structural arrangements.

In June 2011 the CDEM Group approved the review of civil defence emergency management in the Wellington region, the appointment of a Regional Manager for CDEM and the formation of a consolidated Wellington Region Emergency Management Office (WREMO).

Mr Bruce Pepperell, Regional Manager, Wellington Region Emergency Management Office, was appointed in October 2011 and was tasked to carry out a review of the existing CDEM arrangements in the region and to develop a unified structure for approval and implementation.

The new organisation (WREMO) and the associated arrangements were approved at the CDEM Group meeting of 23 March 2012 and the implementation date for WREMO was set for 2 July 2012.

Mr Pepperell needs to be appointed the Group Controller for the Wellington region CDEM Group with effect from 1 July 2012.

Apart from the Group Controller, all other appointments will be reviewed and rationalised and reported to the CDEM Group at its next meeting
