# 5 MCDEM Public Education Programme

The Group received a presentation from Bruce Pepperell, Regional Manager, CDEM, about the MCDEM Public Education Programme.

Since the programme was launched in 2006 there have been changes in the demographics and behaviours of New Zealanders, including an increase in migrants, and in the way we communicate and receive information. People are more confused about what assistance they will actually receive during an emergency and are less prepared as a consequence.

A new programme has been developed with a "Never Happens? Happens" theme. It will focus more on impacts than hazards, such as no internet or no water, and getting people to imagine themselves and their families in various situations without the basic services that they rely on. The programme will be promoted using social media rather than television, as fewer people are now engaging with mainstream television advertising.

### **6 Wellington CDEM Group Welfare Plan**

The Group received a presentation from Charlotte Williams, Group Welfare Manager, and Chair of the Regional Welfare Coordination Group, about the Wellington CDEM Group Welfare Plan 2016-2018.

Mayor Wade-Brown arrived at the meeting during the consideration of this item

The Plan provides direction for a coordinated approach to welfare services provision and was due for review before June 2016. The focus of the review has been alleviating the impact of disasters on communities. It has focussed on the four 'Rs' of:

#### Reduction

- Readiness
- Response
- Recovery

The review has aimed to clarify the roles and responsibilities for all the agencies involved in welfare, including councils. It has been a facilitated process with consultation with all the agencies involved and approval from the CEG.
