Request for information 2025-143

I refer to your request for information dated 1 May 2025 which was received by Greater Wellington Regional Council (Greater Wellington) on 1 May 2025. You have requested the following:

“We are currently looking at a 2nd survey for the Mau Tō Rongo initiative to analyse and determine if the MTR navigator service has been effective. We were wondering if you could supply us with data as per previous but which dates back from perhaps the 22/23 year, and 23/24 year to give us some more comparative data? We would also like to include verbal assault data if this is captured please (all Porirua-specific)?”

The other data set we would like to request (if known) is the use of Snapper cards between the hours of 7-9am and 2.30-6pm (also Porirua-specific), and (if known) include the age grouping (we assume students get cheaper fares so that may show up in the reporting process).”

Greater Wellington’s response follows:

Verbal assault data

This information is still being collated, we will be releasing this information to you by 12 June 2025. Some personal information may be withheld from the data released to you on 12 June under section 7(2)(a) of the Local Government Official Information and Meetings Act 1987 (the Act) on the grounds that the withholding of the information is necessary to protect the privacy of natural persons, including that of deceased natural persons.

Snapper data

On 1 May 2025, an officer contacted you to ask what timeframe you would like the information for and on 1 May 2025 you replied that you would like this information for 2023 onwards.

We have provided the information to you broken down by concession types loaded onto Snapper cards as Greater Wellington does not record information specifically related to the age of passengers.

Attachment 1 contains the patronage numbers for bus routes servicing Porirua by concession type in the AM and PM peak. **Attachment 2** contains information on patronage numbers for buses stopping at Porirua station broken down by concession type in the AM and PM peak. **Attachment 3** contains rail patronage information for Porirua station in the AM and PM peak.

If you have any concerns with the decision(s) referred to in this letter, you have the right to request an investigation and review by the Ombudsman under section 27(3) of the Act.

Please note that it is our policy to proactively release our responses to official information requests where appropriate. Our response to your request will be published shortly on Greater Wellington's website with your personal information removed.
